This past year retirees saw a new Congress come to Washington. The great wave of voter discontent in 2006 led by retirees, who vote in the greatest numbers, elected new majorities to both houses of Congress. For retirees and older Americans, the threats of Social Security privatization, the fallout from the confusing Medicare Part D prescription program, and a tax system skewed toward the wealthiest Americans all contributed to the change in Congress.

Congress considered several important retiree issues. It passed an overdue increase in the federal minimum wage that many older Americans rely on for needed income. Congress also restored pay-as-you-go rules for spending, in an effort to stop the out of control debt that previous Congresses placed on current and future generations. Also, in spite of overwhelming public opposition to Social Security privatization and a new majority, the privatizers in the Senate continued their assault on Social Security. Fortunately, our allies defeated the privatization attempts. Having a more senior friendly Congress allowed for winning more key votes. Yet, we must remain on guard against future efforts to privatize Social Security and remind all Americans that it is a program that benefits all generations, not just retirees.

The Medicare Part D program is still benefiting insurance and drug companies at the expense of beneficiaries. Americans pay the highest drug prices in the world, for drugs that often are developed with our tax dollars. A proposal to allow Medicare to negotiate for drug prices easily passed the House. However, the Senate filibuster rule stymied this common sense legislation. Likewise, efforts to rein in the overpayments in the Medicare Advantage program passed the House but could not survive in the Senate. We are just a few votes away from breaking the stranglehold of the insurance and drug lobbies in the Senate. We need to redouble our efforts so that a minority of senators can no longer stop making changes to Medicare and other vital programs that will help beneficiaries and save tax dollars.

It is up to us to advocate for those issues on which older Americans depend for a respectable quality of life in retirement.

This Voting Record reflects how committed our elected representatives are to retirees and older Americans. Use it to educate yourself on where your elected representatives stand. Get active today and help create an America that protects the health and economic security of seniors, strengthens families and builds safe and thriving communities.

SENATE VOTES

The following is a list of ten key votes selected as representative of the votes of critical importance to retirees taken by the U.S. Senate:

1 Social Security Privatization

Senator DeMint, R-SC, introduced an amendment to the budget resolution that would use current Social Security surpluses to create private accounts. The current surpluses are designed to pay for the benefits of the growing number of retiring baby boomers. The amendment would increase the federal debt by more than \$700 billion over ten years. The amendment failed 45-52. A **NO** vote is the pro-retiree vote. S. Con. Res. 21, Roll Call No. 89, March 22, 2007.

2 Part D Premiums Increase

Senator Ensign, R-NV, introduced an amendment to the budget resolution that would increase Medicare Part D prescription drug premiums based on income. This means-testing approach, already in place for Part B physician premiums, undermines the social insurance basis of Medicare. The amendment failed 44-52. A **NO** vote is the pro-retiree vote. S. Con. Res. 21, Roll Call No. 93, March 22, 2007.

3 Medicare Advantage Subsidies

Senator Hatch, R-UT, introduced an amendment to the budget resolution that would protect Medicare Advantage plans from cuts. Medicare Advantage plans, privately run plans that replace Medicare, have been estimated to drain more than \$10 billion annually from the Medicare Trust Fund. In addition, all Medicare beneficiaries pay an estimated extra \$2 monthly in premiums, regardless of whether they are in a Medicare Advantage plan, because of the overpayments. The amendment failed 49-50. A **NO** vote is the pro-retiree vote. S. Con. Res. 21, Roll Call No. 103, March 27, 2007.

4 Estate Tax Repeal

Senator DeMint, R-SC, introduced an amendment to the budget resolution that would allow for the repeal of the federal estate tax. Repeal of the estate tax benefits only the wealthiest Americans. The loss of revenues threatens the financial stability of the Social Security and Medicare systems. The amendment failed 44-55. A **NO** vote is the pro-retiree vote. S. Con. Res. 21, Roll Call No. 109, March 23, 2007.

5 Pro-Retiree Budget

The Senate passed the annual budget resolution, introduced by Sen. Conrad, D-ND. The resolution included restoration of pay-as-you-go spending, the closing of tax loopholes used by offshore tax havens, and increased resources to combat Medicare waste and fraud. The resolution passed 52-47. A **YES** vote is the pro-retiree vote. S. Con. Res. 21, Roll Call No. 114, March 23, 2007.

6 Negotiate Drug Prices

The Senate defeated a motion to invoke cloture and proceed to a bill that would authorize the Secretary of Health and Human Services to negotiate with drug manufacturers for lower Medicare Part D drug prices. While the Alliance supports mandatory negotiation, this motion was the only opportunity to vote directly on the negotiation issue. The motion failed 55-42. Sixty votes are necessary to invoke cloture. A **YES** vote is the pro-retiree vote. S. 3, Roll Call No. 132, April 18, 2007.

7 Drug Reimportation

Senator Dorgan, D-ND, introduced an amendment to the Food and Drug Administration reform bill that would permit the importation of prescription drugs by registered importers or individuals for personal use if importation did not adversely affect public health. Many Americans have resorted to purchasing drugs from other nations, especially Canada, in order to obtain their needed medicines. The amendment passed 63-28. A **YES** vote is the pro-retiree vote. S. 1082, Roll Call No. 150, May 3, 2007.

8 Limit Drug Reimportation

Senator Cochran, R-MS, introduced an amendment to modify the Dorgan reimportation amendment that would require the Department of Health and Human Services to first certify that any imported drug would pose no additional risk to public health. The department had told Congress that it would not issue certifications, thus killing reimportation. The amendment passed 49-40. A **NO** vote is the pro-retiree vote. S. 1082, Roll Call No. 151, May 7, 2007.

9 Stop Drug Conflict of Interest

Senator Durbin, D-IL, introduced an amendment to the Food and Drug Administration reform bill to allow only one conflict of interest waiver for each drug advisory committee. After one waiver, anyone with a financial interest in a drug would be designated a "guest expert" and barred from committee deliberations. The amendment failed 47-47. A **YES** vote is the pro-retiree vote. S. 1082, Roll Call No. 156, May 9, 2007.

10 Voting Rights Suppression

Senator Dole, R-NC, introduced an amendment to a voting rights bill that would require individuals voting in person to present photo identification. This proposal disproportionately affects older Americans, many of whom do not drive or otherwise need such identification. The amendment failed 42-54. A **NO** vote is the pro-retiree vote. H.R. 2669, Roll Call No. 269, July 19, 2007.

HOUSE VOTES

The following is a list of ten key votes selected as representative of the votes of critical importance to retirees taken by the U.S. House of Representatives:

1 Negotiate Drug Prices

The House passed a bill, introduced by Rep. Dingell, D-MI, that would mandate the Secretary of Health and Human Services to negotiate with drug manufacturers for lower Medicare Part D drug prices. Americans pay the highest drug prices in the world and this bill would reduce prices for retirees. The bill passed 255-170. A **YES** vote is the pro-retiree vote. H.R. 4, Roll Call No. 23, January 12, 2007.

2 Pro-Retiree Budget

The House passed the annual budget resolution, introduced by Rep. Spratt, D-SC. The resolution included restoration of pay-as-you-go spending and provided more resources to reduce the Social Security claims backlog as well as waste and fraud in the Medicare and Medicaid systems. The resolution passed 216-210. A **YES** vote is the pro-retiree vote. H. Con. Res. 99, Roll Call No. 212, March 29, 2007.

3 Retiree Programs Spending I

The House passed an emergency spending bill to fund government services, introduced by Rep. Obey, D-WI. The bill included provisions to increase the federal minimum wage, on which many older Americans rely, as well as Medicaid funding for public hospitals and increased veterans health care spending. The bill passed 218-208. A **YES** vote is the pro-retiree vote. H.R. 1591, Roll Call No. 265, April 25, 2007.

4 Stop Price Gouging

The House passed a bill, introduced by Rep. Stupak, D-MI, that would protect consumers from price gouging for gasoline and other fuels. Recent price increases have created windfall profits for oil companies as well as sharp price increases for consumers. The bill passed 284-141. A **YES** vote is the pro-retiree vote. H.R. 1252, Roll Call No. 404, May 23, 2007.

5 Medicare Advantage Subsidies

Rep. Camp, R-MI, introduced an amendment to the Department of Health and Human Services funding bill that would protect Medicare Advantage plans. Medicare Advantage plans receive subsidies from the Medicare Trust Fund that average more than 12% in extra costs than traditional Medicare. These overpayments shorten the solvency of the Trust Fund by at least two years. In addition, all Medicare beneficiaries pay an extra \$2 per month to subsidize these plans, whether or not they are enrolled in them. The amendment failed 192-228. A **NO** vote is the pro-retiree vote. H.R. 3043, Roll Call No. 675, July 19, 2007.

6 Retiree Programs Spending II

The House passed the funding bill for the Departments of Labor, Health and Human Services and Education, introduced by Rep. Obey, D-WI. The bill included increased funding for research on diseases such as Alzheimer's, Parkinson's, and cancer as well as increased funding for the Social Security Administration. The bill passed 276-140. A **YES** vote is the pro-retiree vote. H.R. 3043, Roll Call No. 686, July 19, 2007.

7 SCHIP/Medicare Advantage

The House passed a bill, introduced by Rep. Dingell, D-MI, that would expand the State Children's Health Insurance Program (SCHIP) and make improvements to Medicare. The improvements included cutting Medicare Advantage overpayments and expanding the Medicare low income subsidy program. The bill passed 225-204. A **YES** vote is the pro-retiree vote. H.R. 3162, Roll Call No. 787, August 1, 2007.

8 Limit Drug Reimportation

Rep. Kingston, R-GA, introduced an amendment to the Food and Drug Administration (FDA) funding bill that would forbid the bulk reimportation of prescription drugs for Internet pharmacies, even though the drugs came from FDA-approved facilities. Many Americans have resorted to purchasing drugs from other nations, especially Canada, in order to obtain their needed medicines. The amendment failed 146-283. A **NO** vote is the pro-retiree vote. H.R. 3161, Roll Call No. 806, August 2, 2007.

9 Override SCHIP Veto

The House attempted to override President Bush's veto of a bill to expand the State Children's Health Insurance Program. The bill expanded the coverage from 6 to 10 million children over five years. Access to health care early in life can prevent disease and illness in old age. The House failed to override the veto 273-156. Two-thirds of those members present and voting are necessary to override. A **YES** vote is the pro-retiree vote. H.R. 976, Roll Call No. 982, October 18, 2007.

10 Mortgage Reform

Rep. Miller, D-NC, introduced a bill to reform the mortgage system, including national standards to stop abusive mortgage practices. In addition, the bill creates protections for renters in foreclosed homes and establishes a housing counseling office at the Department of Housing and Urban Affairs. The House passed the bill 291-127. A **YES** vote is the pro-retiree vote. H.R. 3915, Roll Call No. 1118, November 15, 2007.
