This past year saw dramatic change come to Washington. The November elections provided a bright contrast on the future of retiree issues. Whether to privatize Social Security, continue the wasteful subsidies under Medicare Advantage, and allow the continuance of the confusing Medicare Part D prescription drug program without the ability to negotiate for lower drug prices were all key retiree issues. Voters responded and the result was increased majorities in Congress and a major change in the White House.

Leading up to the November elections, Congress considered several important retiree issues. For the first time, Congress fully funded the low income energy assistance program. Also, like in past years, the privatizers in the Senate continued their assault on Social Security. This assault continued in spite of overwhelming public opposition to privatization. Fortunately, our allies defeated the privatization attempts. Yet, we still must remain on guard against future efforts to privatize Social Security and remind all Americans that it is a program that benefits all generations, not just retirees.

In spite of an administration hostile to real change in 2008, there were some Medicare improvements. Congress overrode President Bush's veto of a Medicare bill that made improvements to the program. The legislation adjusted the asset tests so that more low income beneficiaries can now receive help. The new law also added preventive and mental health benefits. Additionally, the law stopped pending reimbursement cuts to physicians and cut some overpayments to the Medicare Advantage program.

It is up to us to advocate for those issues on which older Americans depend for a respectable quality of life in retirement.

This Voting Record reflects how committed our elected representatives are to retirees and older Americans. Use it to educate yourself on where your elected representatives stand. SENATE VOTES

The following is a list of ten key votes selected as representative of the votes of critical importance to retirees taken by the U.S. Senate:

1 Retiree Stimulus

The Senate defeated a motion to invoke cloture and proceed to an economic stimulus bill. The legislation contained several pro-retiree measures including increased funding for home energy assistance for low income Americans. Many seniors rely on these funds during the winter. The motion failed 58-41. Sixty votes are necessary to invoke cloture. A **YES** vote is the pro-retiree vote. H.R. 5140, Roll Call No. 8, February 6, 2008.

2 Part D Premiums Increase

Senator Ensign, R-NV, introduced an amendment to the budget resolution that would increase Medicare Part D prescription drug premiums based on income. This means-testing approach, already in place for Part B physician premiums, undermines the social insurance basis of Medicare. The amendment failed 42-56. A **NO** vote is the pro-retiree vote. S. Con. Res. 70, Roll Call No. 63, March 13, 2008.

3 Social Security Privatization

Senator DeMint, R-SC, introduced an amendment to the budget resolution that would use current Social Security surpluses to create private accounts. The current surpluses are designed to pay for the benefits of the increasing numbers retiring baby boomers. The amendment would increase the federal debt by more than \$700 billion over ten years. The amendment failed 41-57. A **NO** vote is the pro-retiree vote. S. Con. Res. 70, Roll Call No. 65, March 13, 2008.

4 Long Term Care Workers

Senator Kohl, D-WI, introduced an amendment to the budget resolution that would fund a nationwide comprehensive system of background checks for long term care workers. A seven-state pilot program already stopped more than 7,200 people with criminal records from becoming long term care workers. The amendment passed 89-7. A **YES** vote is the pro-retiree vote. S. Con. Res. 70, Roll Call No. 68, March 13, 2008.

5 Undermine Health Insurance

Senator DeMint, R-SC, introduced an amendment to the budget resolution that would undermine employer-provided health insurance by providing tax incentives to purchase individual insurance outside the workplace. The amendment undermines the cost savings that come with group insurance and the ability for employers to offer retiree coverage. The amendment failed 45-51. A **NO** vote is the pro-retiree vote. S. Con. Res. 70, Roll Call No. 82, March 13, 2008.

6 Drug Reimportation

Senator Vitter, R-LA, introduced an amendment to the budget resolution that expressed the sense of the Senate of the need to pass comprehensive legislation to legalize the safe importation of prescription drugs from nations with safe pharmaceutical infrastructures. Many Americans have resorted to purchasing drugs from other nations, especially Canada, in order to obtain their needed medicines. The amendment passed 73-23. A **YES** vote is the pro-retiree vote. S. Con. Res. 70, Roll Call No. 84, March 14, 2008.

7 Medicare Cloture

The Senate defeated a motion to invoke cloture and proceed to a Medicare bill. The legislation would reform Medicare Advantage sales and marketing activities, eliminate late enrollment penalties, and expand eligibility for low income assistance. The motion failed 54-39. Sixty votes are necessary to invoke cloture. A **YES** vote is the pro-retiree vote. S. 3101, Roll Call No. 149, June 12, 2008.

8 Medicare Improvements

The Senate passed a bill that strengthened Medicare by adjusting asset tests so more low income seniors can obtain assistance, added preventive and mental health benefits, reduced pending physician reimbursements and cut some overpayments to Medicare Advantage fee for service plans. The bill passed 69-30. A **YES** vote is the pro-retiree vote. H.R. 6331, Roll Call No. 169, July 9, 2008.

9 Medicare Veto Override

The Senate overrode President Bush's veto of the Medicare legislation. The override vote was 70-26. Two-thirds of those members present and voting are necessary to override. A **YES** vote is the pro-retiree vote. H.R. 6331, Roll Call No. 177, July 15, 2008.

10 Retiree Programs Funding

The Senate passed a continuing appropriations bill that contains several key retiree program provisions. Included were \$5.1 billion for the Low Income Home Energy Assistance Program (LIHEAP), the first full funding of the program, as well as \$477.2 million for the Weatherization Assistance Program. The bill passed 78-12. A **YES** vote is the pro-retiree vote. H.R. 2638, Roll Call No. 208, September 27, 2008.

HOUSE VOTES

The following is a list of ten key votes selected as representative of the votes of critical importance to retirees taken by the U.S. House of Representatives:

1 Pro-Retiree Budget

The House passed the annual budget resolution, introduced by Rep. Spratt, D-SC. The resolution included the rejection of President Bush's proposed \$196 billion cuts in Medicare and Medicaid spending over five years. The resolution passed 212-207. A **YES** vote is the pro-retiree vote. H. Con. Res. 141, Roll Call No. 312, March 13, 2008.

2 Election Assistance

The House debated a bill introduced by Rep. Holt, D-NJ, that would give state and local governments financial assistance for the costs of obtaining election systems with paper backups for the November 2008 elections as well as for costs associated with auditing and hand counting of election results. The bill failed 239-178. Two-thirds of members present and voting are required under the House's suspension calendar rules. A **YES** vote is the pro-retiree vote. H.R. 5036, Roll Call No. 188, April 15, 2008.

3 Medicaid Moratorium

The House passed a bill introduced by Rep. Dingell, D-MI, that placed a one year moratorium on seven Bush Administration Medicaid regulations. The most common Medicaid beneficiary is a nursing home patient. Had the regulations taken effect, federal spending on critical programs would decline by \$20 billion and state and local governments would have to absorb those costs. The bill passed 349-62. A **YES** vote is the pro-retiree vote. H.R. 5613, Roll Call No. 209, April 23, 2008.

4 Prevent Home Foreclosures

The House passed a bill, introduced by Speaker Pelosi, D-CA, to help families facing home foreclosure. The bill provides \$300 billion in government loan guarantees to assist in home refinancing. Older Americans have not been spared in the current housing crisis. The bill passed 256-160. A **YES** vote is the pro-retiree vote. H.R. 3221, Roll Call No. 303, May 8, 2008.

5 Medicare Improvements

The House passed a Medicare improvement bill, introduced by Rep. Rangel, D-NY, that helps beneficiaries. The bill updates asset levels so more low income seniors can receive assistance, adds preventive and mental health services benefits, and stopped pending cuts to physician reimbursement rates. The bill passed 355-59. A **YES** vote is the pro-retiree vote. H.R. 6331, Roll Call No. 443, June 24, 2008.

6 Medicare Veto Override

The House overrode President Bush's veto of the Medicare legislation. The override vote was. The override vote was 383-41. Two-thirds of those members present and voting are necessary to override. A **YES** vote is the pro-retiree vote. H.R. 6331, Roll Call No. 491, July 15, 2008.

7 Ballot Integrity

The House debated a bill, introduced by Rep. Lofgren, D-CA, that would make grants to state and local governments in order to create backup paper ballot voting in case of electronic machine failures during the 2008 elections. Machine failures in past elections caused long lines at the polls in many instances. The bill failed 248-170. Two-thirds of members present and voting are required under the House's suspension calendar rules. A **YES** vote is the pro-retiree vote. H.R. 5803, Roll Call No. 493, July 15, 2008.

8 Eliminate Medicare Trigger

The House changed its rules regarding the so-called 45% Medicare trigger in a resolution introduced by Rep. Hastings, D-FL. The Medicare Modernization Act of 2003 arbitrarily mandated that if the President determined that 45% of Medicare funding came from general revenues for two consecutive years, then the President would propose Medicare cuts. The trigger is a misleading indicator of the financial stability of Medicare. The resolution passed 231-184. A **YES** vote is the pro-retiree vote. H. Res. 1368, Roll Call No. 532, June 24, 2008.

9 Stop Elder Abuse

The House passed a bill, introduced by Rep. Sestak, D-PA, to protect older Americans from elder abuse. The bill would require the U.S. Attorney General to study state elder abuse laws and practices, train prosecutors and law enforcement officers, and make recommendations for better protections against elder abuse. The bill passed 387-28. A **YES** vote is the pro-retiree vote. H.R. 5352, Roll Call No. 626, September 23, 2008.

10 Retiree Programs Funding

The House passed an appropriations bill that contains several key retiree program provisions. Included were \$5.1 billion for the Low Income Home Energy Assistance Program (LIHEAP), first full funding of the program, as well as \$477.2 million for the Weatherization Assistance Program. The bill passed 370-58. A **YES** vote is the pro-retiree vote. H.R. 2638, Roll Call No. 632, September 24, 2008.
