# Social Security and Medicare: 2025 Facts and Figures

### The Many Faces of Social Security

- Nearly 185 million workers contribute to Social Security through payroll taxes.
- Over 74 million people receive monthly Social Security benefits:
  - o Nearly 58 million people receive retirement benefits
  - o 5.8 million people receive survivors' benefits
  - o 8.4 million people receive disability benefits.
- Beneficiaries by state

# Average January 2026 Monthly **Social Security Benefit**

A retired worker: \$2,071 A retired couple: \$3,208 Disabled worker: \$1,588

Disabled worker with spouse and child: \$2,520

Widow or widower: \$1,919

Young widow or widower with two children: \$4,100

Maximum Monthly Social Security Benefit: \$4,152 (for worker retiring at Full Retirement Age).

### Social Security Cost of Living Adjustment (COLA) for 2026: 2.8%

### 2026 Social Security and Medicare **Contribution Amounts**

**Social Security:** 6.2% for both workers and employers. This contribution is paid on earnings up to \$184,500.

**Medicare:** 1.45% for both workers and employers on all wages.

### Social Security Eligibility

Full Retirement Age: Depends on your birth year.

**Early Retirement Age:** 62 (drawing benefits before the full retirement age can reduce Social Security benefits up to 30 percent)

### Social Security: When and How to **Apply for Benefits**

### The Many Faces of Medicare

- Nearly 186 million workers contribute to Medicare through payroll taxes.
- Approximately 69 million people receive Medicare benefits, including:
  - o 61 million people age 65 and older
  - o 7.6 million people with disabilities under 65
- Beneficiaries by state

## 2026 Medicare Part A (Hospital Coverage)

Deductible: \$1,736 (first 60 days of Medicare-covered inpatient hospital care) Coinsurance: \$0 (Days 1-60), \$434 per

day (Days 61-90)

### 2026 Medicare Part B (Physician Coverage)

For all beneficiaries: Part B deductible is \$283 and the Part B copayment is 20%.

### 2026 Medicare Part D (Prescription Drug Coverage)

Monthly Premium: Varies by plan

**Deductible:** Varies by plan, \$615 maximum

Doughnut Hole: Eliminated under the Inflation

Reduction Act.

Cap on out-of-pocket Costs: \$2,100

In addition to a monthly plan premium, highincome individuals will pay an income-related monthly adjustment amount as noted below:

### Medicare: When and How to Apply for Benefits

Medicare is available for people age 65 or older, younger people with disabilities and people with End Stage Renal Disease. If you sign up after you turn 65, you may be penalized unless you have other coverage.
