April 27–30, 2026 | Sahara Hotel Las Vegas

Join retiree activists from across the country for ***Retiree Power: 25 Years and Growing, the Alliance for Retired Americans' 2026 National Membership Meeting.***

This special gathering marks our **25th anniversary** and will bring members together to elect national officers, debate and vote on resolutions, and prepare for the high-stakes 2026 elections. The meeting kicks off with a welcome reception at the Sahara Hotel Las Vegas on April 27 and wraps up by noon on April 30.

Participants will hear from exciting speakers, attend engaging workshops, participate in national strategy discussions, network with fellow retiree activists, and attend our 25th Anniversary Senior Prom Ball and Dinner. Let's dress up a bit!

The registration fee is \$150 and covers all meeting activities, as well as most meals.

The hotel rate is \$69 per night, plus tax. There is no resort fee.

The deadline for registration and hotel reservations is April 10, 2026!

WHAT HAPPENS AT THE NATIONAL MEMBERSHIP MEETING?

OFFICER ELECTIONS

All delegates will elect a President and Secretary-Treasurer. At-Large/Community-based delegates will also elect six At-Large Directors and the Executive Vice-President for Community Affairs.

At-Large members in good standing **as of February 26, 2026** may be nominated at the At-Large/Community-Based Caucus during the convention to serve as an At-Large director/CAN Board Member.

Union-affiliated members whose dues are paid by their unions are not eligible to vote or be a candidate in the At-Large/Community-Based delegate Caucus.

EDUCATIONAL WORKSHOPS & SPEAKERS

Attend workshops that will strengthen your organizing and advocacy skills. Hear from experts in Social Security, health care, aging and politics. The national meeting is a great time to make connections and learn from fellow activists. All sessions are designed for new and experienced activists alike!

Who can vote at the national meeting?

Any individual whose Alliance membership is paid for by a sponsoring organization is eligible to be a voting delegate.

Any individual who pays for their own Alliance membership and is in good standing **as of February 26, 2026** (60 days before the meeting) is eligible to be a voting delegate. These members are also called "self-enrolled" or community based members.

State Alliance chapters and local Alliance chapters may assign delegates as described in the Alliance bylaws.

DEBATE AND VOTE ON RESOLUTIONS

Help shape the Alliance's agenda. Members will debate and vote on policy resolutions that guide our work nationwide. Proposed resolutions must be submitted in advance.

Any delegate registered to attend the National Convention may offer or second a resolution for consideration. Resolutions must pertain to a statement of the Alliance's position or policy on a specific matter.

Resolutions, and seconds, must be received by the Alliance **no later than April 6, 2026**.

The Resolutions Committee, designated by the Alliance President, will review proposed resolutions. Submit proposed resolutions to AllianceResolutions2026@retiredamericans.org.

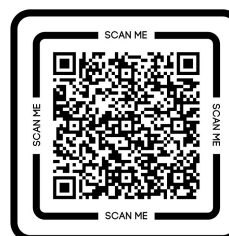
